#### X. COMMITTEE MEMBER / LIAISON COMMENTS AND QUESTIONS

Assemblymember Woll gave an update from last night's Assembly meeting. The Assembly passed Ordinance 2021-26(am) an ordinance amending the Official Zoning Map by Rezoning Channel View Lot 1, Located near 4650 North Douglas Highway from D15 to Light Commercial. The Assembly wanted to emphasize all the work the SRRC did and appreciated the recommendations the committee brought to the Assembly.

Ms. Casulucan asked Assemblymember Woll to expand on what lead the Assembly to vote to allow the rezone and the overall thoughts from the Assembly after seeing the heated debate on social media within the community around this topic.

Assemblymember Woll stated there had been voiced concern within certain aspects of the community that the creation of the SRRC would steer the Assembly in its decision-making process. The Assembly pushed back on those concerns and stated their appreciation for the recommendations the SRRC brought forward to the Assembly; noting the committee is doing exactly what its charge states – reviewing legislation and bringing forward any potential issues they see. The Assembly appreciated Chair Worl and Ms. Lee attending the Committee of the Whole meeting and reporting out how the SRRC had come to its recommendations for the rezone ordinance.

Ms. Lee thanked Assemblymember Woll for the update and remarked that the SRRC recommendation regarding the rezone was to get public comment; and generally appreciated the comments received from the public. It was a successful process and highlighted areas where process flow can improve between SRRC and the Assembly for future recommendations.

Ms. Casulucan said the SRRC role is advisory and to bring to the Assembly another lens and provide tools to view issues that concern the community; the committee is not here to impede or hold up any decisions. The ultimate decision-making process is up to the Assembly. The SRRC meetings are available to the public and Ms. Casulucan thanked Alex Smith for giving public testimony today.

Chair Worl observed that each member brings a different experience and insight in which to view the community and our role is to review the ordinances that come before us. She appreciated the trainings the committee took in the spring and hoped that future committee members would be able to view those trainings as well. Chair Worl hoped that with the committee using the toolkit it created to review legislation it will help everyone creating legislation to get in the habit of looking at legislation through those equity lens's.

Assemblymember Woll reported on several other topics discussed during the February 7 Assembly meeting; the Assembly had a conversation about sales tax exemptions regarding food, a topic that has been a goal of the Assembly for quite some time, recognizing it is an equity issue. Assemblymembers said they want to take this goal on and the SRRC will most likely see that issue come before them in the future. The Assembly Human Resources Committee will hold interviews for the two open SRRC seats on February 17 at 5:30pm via zoom webinar. The Assembly Human Resources Committee also discussed zoom bombing and what the Assembly would like to do for better protections for committees as well as the Assembly while still allowing for public testimony. The Committee of the Whole will discuss public

participation and Assembly rules and procedures at its Monday, February 14 work session.

Chair Worl thanks Assemblymember Woll for the updates and noted that accessibly and public testimony is important and appreciated. Chair Worl asked committee members if they would like to meet on February 15, 2022 for a presentation from Scott Ciambor regarding housing and homelessness in Juneau. SRRC members agreed to meeting on February 15 for the presentation on housing and homelessness.

Purpose of Legislation (background/summary of intent):							

This legislation is for the purchase of a used Gondola Ski Lift from Austria. A Gondola Ski Lift has a series of enclosed cabins to transport recreationalists and visitors up the mountain protected from the elements. This legislation is moving faster than typical legislation to allow Eaglecrest / CBJ to acquire this Gondola out of a very competitive market of used Chair Lifts and Gondolas. The majority of second hand Gondolas that become available do not have the ability to load and unload half way up the lift which will be the key component that will allow Eaglecrest to increase it's accessibility in the winter while also creating more resiliency to climate change. The purpose of this acquisition is to increase accessibility of Eaglecrest to serve a wider segment of the Juneau population in all seasons.

#### **Process and Public Engagement:**

Eaglecrest has been working on this project since the summer of 2019 and have evaluated many development alternatives. Some of these alternatives contemplated the purchase of a brand new Gondola. Due to recent, demand for ski lift replacements and inflationary pressures on materials the price for new lifts have increased by 25% bringing the cost of a new Gondola that has the same capabilities as the Gondola contemplated in the ordinance up to \$23 Million. The contemplated Gondola is a very solid and affordable machine that will have a 30-year life span allowing Eaglecrest to affordably increase accessibility to the mountain 12 months out of the year.

During the last Eaglecrest Master Plan update in 2012 the McDowell Group performed extensive public surveys through online, telephone and mail with over 1200 respondents. One of the top responses received was for more summer activities. When Eaglecrest began our planning process on this project in 2019 we performed an online survey that received 147 total respondents to solicit feedback on the project and understand top activities of users in summer and winter.

#### **Demographics and Programming geared toward Accessibility:**

The hopes of this expansion project is to allow Eaglecrest to create more part time and year around job openings. We do not currently have detailed demographic information from our users and employee base. We do typically have a number of minorities that are employed as lift operators, summer laborers and Snowsports instructors. Eaglecrest provides a free daily employee shuttle to transport employees to and from the mountain with pickup locations around all sections of town.

We have numerous programs dedicated to providing accessibility to at risk youth and minorities. The Books to Boards program provide free bus transportation to and from the mountain, lift tickets, ski and snowboard rentals, ski and snowboard lessons and accessibility to all winter clothing needed to have a fun day on the mountain. Average annual enrollment is 60 to 80 students annually. The program has been running for over 10 years. Some of the early students enrolled in the program have become returning employees and have now found a new welcoming community based on healthy activities and life styles.

Eaglecrest also has the 5<sup>th</sup> grade passport program, which ensures that Eaglecrest is accessible to all 5<sup>th</sup> graders by allowing free skiing and snowboarding for the entire 5<sup>th</sup> grade year for all youth in Juneau. The program also provides one lesson at the start of the season to ensure the youth get started out with the basic skills to navigate the slopes. Many studies have been done showing that during this age range youth have the good dexterity and are able to quickly learn the basic skills quickly.

This year Eaglecrest is sponsoring 14 students from the Yaakoosgé Alternative High School to learn skiing and snowboarding as an alternative to traditional physical education. The program is geared toward creating a positive physical outlet to promote mental health and well-being. Eaglecrest introduces these youth to an entirely new segment of the community that is inclusive and supportive.

All school groups typically visit Eaglecrest for a field trip day and have the chance to try Skiing and Snowboarding at extremely discounted rates to ensure accessibility to Juneau youth of all ages.

Eaglecrest has specific programs with the girls and boys Lighthouse program that gives accessibility to the at-risk youth enrolled with the Lighthouse program.

Eaglecrest has a working relationship with the Tlingit and Haida youth program to ensure accessibility to them and teach them the skills to ski and snowboard and bond with nature in a new way.

When the youth that are engaged in all of the above programs come with their friends and find the freedoms of being on the mountain, teachers and counselors have notice very positive changes in their mental health and engagement in their school work and peers. Often times their ski and snowboard, Instructors continue to mentor them and become new friends and the first support structure that they have at the mountain. The snow bus that runs on weekends and holidays throughout town ensures ongoing accessibility to these youth after their initial experience without needing a parent or guardian with a vehicle to get them to the mountain.

The ski and snowboard community is very unique in this day in age as it is a true melting pot and cross section of the population that come up to share in the joys of skiing and snowboarding despite political beliefs social status or other orientations. Our users are all bonded together by the unity they achieve with nature and the experiences they share together.

#### **New Expanded Accessibility:**

Installation and operation of this Gondola will create the ability for new activities that will be low cost and accessible to all walks of life in all seasons. In the winter, we plan to bring back our snow-tubing park that will be at the midway load and unload station of the Gondola. Being that the Gondola is an enclosed cabin non-skiers will be able to ride up and down year around. Snow tubing is a thrilling ride that does not require any skill physical fitness that is accessible to all ages and demographics.

Eaglecrest will also be grooming a new network of Nordic Ski trails at the midway loading station that will have the most dependable snow conditions in Juneau. Nordic Skiing equipment is much more affordable than alpine ski and snowboard equipment and is easier to learn making this a winter sport that is very accessible to all walks of life.

During the Summer the Gondola will have low cost daily lift tickets and will provide access to the high alpine ridgeline were a network of casual hiking trails will be located.

Revenue Generated from sightseeing rides to summer cruise tourist will allow Eaglecrest to continue expanding our outreach and discounted school programing in the winter as well as the spring summer and summer seasons. Developing a new summer revenue stream will also allow Eaglecrest to keep all of the existing pricing where it is at which is well below ski industry average pricing.

Ordinance 2021-08(b)(am)(Z) An Ordinance Appropriating up to \$2,000,000 to the Manager for the Purchase of a Used Gondola for Eaglecrest Ski Area; Funding Provided by General Funds.

#### MANAGER'S REPORT:

Eaglecrest staff has identified a used gondola (an aerial mountain lift with enclosed cars as opposed to open chairs) in Austria that can be purchased for \$2,000,000; inclusive of the shipping to Juneau. The gondola is appropriately sized and scaled for installation at Eaglecrest to facilitate all-season access to the top of the mountain. This ordinance would appropriate general funds for the purpose of purchasing the gondola and getting it delivered to Juneau. Once received, the gondola could not be installed until Eaglecrest secures additional funding for the necessary mountain improvements—including the base station, towers, and summit station—necessary to facilitate the installation, estimated to be an additional \$4,500,000.

Assembly Finance Committee reviewed this request at the February 2, 2022 meeting.

#### **RECOMMENDATION:**

The Manager recommends the Assembly introduce this ordinance, refer it to the Committee of the Whole, and set it for public hearing at the next regular Assembly meeting.

Dear Chair Worl -

In preparation for the upcoming SRRC meeting, here are a number of housing and homelessness resources for the committee to take a look at:

- Two onboarding memos are in the packet that were provided to the recently seated Assembly in October that give general updates on housing programs and homelessness efforts;
- As part of the <u>April 2021 Housing Action Plan (HAP) update</u>, a spreadsheet was created that lists HAP activities by year since 2016 in the categories of funding, land assets for housing, and planning, zoning, and policy changes. There is a tab for a funding pie chart as well. Spreadsheet to be updated in the new year.

Also, there are two meetings next week that may be of interest to the committee with packets to be available shortly. Both meetings to take place on Monday, November 29<sup>th</sup>, 2021.

- Lands, Housing, and Economic Development will discuss 2021 Juneau Affordable Housing Fund Recommendations (5pm); and
- The Committee of the Whole will receive an update from the Juneau Coalition on Housing and Homelessness (6pm).

#### October 25, 2021

The CBJ Housing Program is based in the City Manager's Office and was created to further the Assembly's goals of increasing more affordable housing and implementing initiatives developed in the Housing Action Plan. Scott Ciambor, Chief Housing Officer can be contacted with questions about these programs.

For the past year, housing-related activities have been reporting to the CBJ Lands, Housing, and Economic Development Committee.

#### **Housing Programs**

CBJ currently has three incentive programs active and available to the public. Information on each program is online or available on request.

#### **CBJ Homeowner Accessory Apartment Incentive Grant Program:**

Staff provided a program update at the August 30, 2021 <u>LHED Committee meeting</u>. Twenty-seven (27) accessory apartments grant program have been created, received certificates of occupancy, and been awarded \$6000 in funding. Nineteen (19) projects are currently in the process of the grant program. Funding is available through FY23.

CBJ Mobile Home Loan Down Payment Assistance Program: CBJ has partnered with True North Federal Credit Union (TNFCU) to create a program that provides low interest loans to qualified residents for up to 50% of the down payment. Residents must be able to match the other 50%. Loans are available at 1% interest and are not to exceed \$10,000. The borrower has up to five (5) years to pay back the loan. \$100,000 was allocated from the Juneau Affordable Housing Fund to implement the program in September 2016. There have been 13 loans totaling \$79,315 with \$32,187 in principal payments already returned to the fund for re-use.

<u>Juneau Affordable Housing Fund</u> (JAHF): In July 19, 2010, the CBJ Assembly passed an ordinance that steered \$400,000 into the JAHF to fund local projects that promote and provide affordable housing in Juneau. On July 1, 2021 the Assembly made available \$700,000 for a competitive fund round. Applications are <u>due October 29, 2021</u>. All details located on the JAHF webpage.

#### **Housing Action Plan**

The Housing Action Plan was adopted by resolution on December 19, 2016. It is a 30-year action plan to address significant and long-standing housing challenges with a wide variety of tools. The Plan and the latest April 2021 update can be found on the website.

At the September 27, 2021 LHED meeting, a memo was provided with a list of short-term activities:

• <u>The Annual Point-In-Time Homeless Count takes</u> place each January. Data is used by the federal government to make funding decisions.

• The Alaska Management Homeless Management Information System (AKHMIS) provides <u>daily data on persons</u> experiencing homelessness that are utilizing local housing and social services in the community. Attached (pg. 3) is a summary of individuals served and demographic details for 01/01/2021 to 08/31/2021.

Policy direction from the Assembly has come through a couple of taskforces that have taken place in recent years.

• 2017 CBJ Taskforce on Homelessness: The CBJ Assembly Taskforce on Homelessness held six meetings between June 13 – September 12, 2017 with the purpose of holding a conversation on the issues regarding homelessness in Juneau and to report back to the Assembly. Key documents, meeting minutes, and final recommendations can be found on its own webpage.

Final recommendations included 1) establish a cold weather shelter, 2) support additional permanent supportive housing opportunities, 3) support local efforts to create and Assertive Community Treatment team, and 4) establish a Housing and Homelessness Services Coordinator to help the Juneau Coalition on Housing and Homelessness establish a coordinated entry system.

#### • 2020 Mayors ad hoc Committee on Homelessness:

The Mayor's ad hoc Committee on Homelessness (Committee) held three meetings between October 8 and October 29, 2020 with the purpose of holding a conversation on the issues regarding homelessness in Juneau and report back to the Assembly. Final recommendations included:

- Support the establishment of a youth shelter;
- Support Juneau Coalition on Housing and Homelessness long-range planning and resource development;
- Appoint an Assembly liaison to JCHH (2021: Michelle Hale); and
- Provide an opportunity for an annual JCHH Update to the Assembly (November 29, 2021 Committee of the Whole)

#### Quarantine and Isolation Taskforce for Persons Experiencing Homelessness

Since the start of the pandemic, the Housing Office has facilitated taskforce meetings that include at least six different CBJ Departments (Emergency Operations, Parks and Rec, Docks & Harbors, Housing Office, CCFR/Mobile Integrated Health, Lands), Public Health, Bartlett Regional Hospital, SEARHC Front Street Clinic, AWARE, Glory Hall, St Vincent DePaul, hotel providers, and the Juneau Arts and Humanities Council.

The taskforce monitors surveillance testing, vaccine rollout, and quarantine and isolation options for persons experiencing homelessness.

After a reprieve in the spring, the taskforce ramped up to multiple meetings per week in July-August as the Delta variant reached the community and homeless population.

#### **Isolation Services**

- April 36 bed nights
- May 18 bed nights
- June 10 bed nights
- July 94 bed nights
- August 308 bed nights

In early August, hotel availability for isolation in the community was extremely low (zero vacancy on some nights). On August 19<sup>th</sup>, 2021, on a day of surveillance testing for 140 people, Centennial Hall was quickly put into operation to handle a volume of cases needing potential isolation.

Only 1 person needed the service that evening and the individual was referred to a hotel room the following night when a spot became available.

Isolation Services at Centennial Hall during the pandemic

- May 19-24, 2020 = Quarantine after testing event
- Oct. 13 Dec. 6, 2020 = Isolation services for COVID+
- August 19-20, 2021 = Isolation services for COVID
