 - A) Question of the Month

The question of the month was, "Of the three initiatives the JCOA is currently actively working on, the Southeast Regional Eldercare Coalition, Livable community designation through AARP, and the AARP Senior Playground Equipment Grant, which one excites you the most?"

B) Assembly Update

Emily noted that she has requested that the JCOA get on the assembly's agenda to discuss the AARP Livable Community Designation. Alicia replied that she was the correct contact for that and will work to be sure this happens. There is discretion from the committee chair, and sometimes the agendas get rearranged it takes a little longer to get in front of the assembly. She also noted that if people want to get in front of the assembly, they can also contact the clerk's office.

The assembly and met and the long-range waterfront plan was amended, regarding the sub port dock. This does not mean for certain that there will be a dock, but it opens up the path to do that and moves the process into the next step of the public process. The assembly members that voted for it are open for opening up the process and not necessarily set on the dock itself.

Emily asked if the city can make grants conditional, such as needing to build in senior friendly portions to the development. Alicia noted that yes, the city can make grants conditional. Usually, they are more about parking lots or building size, but it is possible to make them conditional.

The HR committee met and there was a resolution regarding Ukraine, that called for suspension of Junea's sister city in Russian, but it was delayed and did not move forward.

Emily has also met with Trail Mix, they will not be applying for an AARP Community Challenge Grant this year. There was discussion on having a celebration when the piece of equipment is installed. Carol noted they have 10 letters of support, and Ann will help facilitate an additional letter of support from Tlingit Haida. Emily asked that each JCOA member go into the grant application and look at the deliverables and provide her with feedback. The grant is due on March 22, 2022.

D) Livable Community Designation

Linda reported that she had a meeting with Teresa Holt, the director of AARP Alaska with several other representatives. Anchorage is applying for the same designation as Juneau, and is a couple steps ahead, so hopefully Juneau can follow their lead. Linda is working on a Power Point presentation to use around Juneau to get support before taking it to the assembly and moving it forward. E) Update on the Southeast Regional Eldercare Coalition

Jennifer reported that a grant was submitted to the Mental Health Trust this morning, to request interim funding for a program coordinator to help the Coalition along. The Coaliton has

come so far from the time when it was just Jennifer and Anne meeting, and it's been great to watch it blossom. Jennifer also appreciates that the Coalition is looking regionally. She noted that at each Coalition meeting we look at best practices in communities and see how we can move some of those practices into other communities, and that Linda has been pivotal in helping with the Best Practices aspect of each Coalition meeting. Legislatively this year, the Coalition is supporting AgeNET and AARP in their efforts. Deb and Linda are partnering on a next stage grant to the Murdoch Trust that would specifically fund staffing for an executive director.
